



Shock: Tennessee Technocrats Plan ‘Wellbeing Checks’ For All Children

Apparently, parents are all suspects in Tennessee. And apparently, in the eyes of officials, government must oversee parents’ parenting to ensure that parents care for their children — and families must prove their innocence. With that in mind, authorities launched a totalitarian federally funded plan that shocked the state and all of America.

Faced with a massive public outcry of unprecedented proportions, Big Brother did hit the pause button on the radical program sending government bureaucrats to interrogate every child in Tennessee under the guise of performing a “wellbeing check.” However, state officials are not giving up yet. Great danger remains.

The scandal began last week, when the Tennessee Department of Education released a “toolkit on child wellbeing checks.” The announcement unveiled a totalitarian plan to invade every family home in the state on a monthly basis. Homeschoolers, private school children, and government-school children were all in the cross-hairs.

“Since we know many children have experienced adversity due to the pandemic, child wellbeing checks are a deliberate way all stakeholders in the community can help ensure the needs of our children are met,” said “Education” Czarina Penny Schwinn, as if “stakeholders,” rather than parents, were in charge of caring for “our” children.

The taskforce’s goals included to, on a monthly basis, “verify the wellbeing and identify needs of all Tennessee children” with “monthly child wellbeing calls.” Also on the agenda was to have “communities” (read: government bureaucrats) “come together to check on our kids and support the holistic needs of Tennessee children.”

It was not clear where Commissioner Schwinn got the totalitarian idea that children in her jurisdiction belong to the government — a noxious idea peddled by tyrants ranging from National Socialist (Nazi) leader Adolf Hitler to International Socialist leaders such as Mao and Stalin. Nor was the concept of “holistic needs” defined.

But according to Schwinn, who was appointed by RINO (Republican In Name Only) Governor Bill Lee, bureaucrats — not parents — are already doing a great job providing for the “holistic needs” of “their” children. “I am encouraged by the hard work and dedication of the Task Force and our districts to support kids and their holistic needs,” she said.

According to documents obtained by The Newman Report, these “wellbeing checks” include in-home interviews of children, preferably without parents around. The “checkers” are instructed to speak with the

child “directly and as privately as possible.” Parents who refuse to allow it would be entered into a database for unspecified purposes. The goal is to have the government check on every child in the state, from birth to age 18.

They are also supposed to “gauge general stress level” and try to push government “services” on families, including the provision of “devices.” Everything from food, transportation, and housing to dentistry, “hygiene procedures,” “mental health,” and vaccines are included in documents about what the government is seeking to meddle in.

After an enormous outcry from lawmakers, civil-liberties advocates, families, taxpayers, and non-totalitarians everywhere, the state “Education Department” withdrew the “toolkit” and promised to “revise it.” “We’ve updated the language for its actual intent, but there is there’s no big brother,” claimed Commissioner Schwinn after the firestorm.

But it’s not over. “It is very obvious to me and others this was not meant to be a short term project,” education expert and former Tennessee County Commissioner Karen Bracken told The Newman Report. “It stated in the policy that it was to be implemented during and AFTER Covid. This smells suspiciously like the home visits and partnering with parents from ESSA [the federal Every Student Succeeds Act].

Calling for authorities to allow life to get back to normal, Bracken also said that Tennesseans will refuse to accept any revision or re-branding. “No matter what warm and fuzzy words you wrap around this policy it is a total violation of our Constitutional rights and an overreach into an area in which they have no authority,” she said. “It is felt they are using COVID as the excuse to implement a plan that has been in the works for quite some time.”

Grounded: Delta Bans Travelers Who Refuse To Wear Masks

A Delta flight from Detroit turned around after some passengers removed their masks and then refused to put them back on. It has now created a “no-fly list” for such cantankerous travelers who will not be allowed on any Delta flight in the future. Will refusing to wear a face mask soon be equated to terrorism? □ TN Editor

Delta Air Lines has placed more than 240 people on a “no fly list” for failing to comply with its mandatory mask policy, CEO Ed Bastian said in a memorandum to employees on Thursday.

“Although rare, we continue to put passengers who refuse to follow the required face-covering rules on our no-fly list,” Bastian said in the memo, which highlighted the airline’s new hub facility in Salt Lake City.

There is currently no federal mandate on masks in airports or on airplanes, forcing each airline to implement its own regulations.

Delta customers and employees are required to wear a face mask or appropriate cloth face covering over their nose and mouth throughout their travel, aligning with best practice guidelines from the CDC, according to the company's website.

"As we all work toward the recovery, it's vital that we continue to stay focused on the drive to provide the safest, cleanest airports, aircraft and workspaces possible," Bastian said.

Face coverings are required across all Delta touchpoints, including the lobby check-in, Delta Sky Clubs, boarding gate areas, jet bridges, and onboard the aircraft, with the exemption of limited time while eating and drinking.

Passengers on major U.S. airlines are required to check a box that confirms they will follow the airline's mask rules, and airline gate agents can deny boarding to anyone not wearing a mask prior to a flight, Reuters reported.

Delta said they continue to find ways to keep passengers safe aboard flights.

"We also are rolling out a new program, developed in partnership with our expert advisors at the Mayo Clinic, to proactively identify U.S. counties currently experiencing a higher risk of COVID-19 spread," Bastian said. "On a weekly basis going forward, we plan to notify Delta people living in these "high risk" counties via targeted email so they can take appropriate precautions to protect themselves and their families."

Apple And Google Now Modifying Phones To Include Full Contact Tracing

Apple and Google power almost every smart phone on earth and now they have jointly agreed to build a full contact tracing app into their core operating systems. This means that an Android phone can 'rat' on an iPhone, and vice versa. The door is now wide open for a ubiquitous global command and control system for every person on earth.

Last May, both Google and Apple rolled out changes to their core operating system that included hooks for App developers to build tracing apps. The tech giants will allow state health agencies to use the software without creating a customized app

Apple and Google said Tuesday they're expanding coronavirus warning software so that state health agencies can participate without having to create customized apps.

The new option, called "exposure notifications express," removes one of the key barriers to adoption that led to a slow start to the software, which can warn people when they come in close contact with someone who has been diagnosed with the coronavirus. So far, only six U.S. states have created apps that work with Apple and Google's software.

The software, which is built into the operating systems on Google's Android phones and Apple's iPhones, uses Bluetooth to tell whether people have spent significant time near one another. If a participant in the exposure notification program tests positive for the coronavirus, that person's close contacts may get a notification.

"I would say this is an improvement," said Jeffrey Kahn, director of the Johns Hopkins Berman Institute of Bioethics. Kahn, who has been studying the use of technology to fight the virus, said states have been hamstrung by indecision around which technology vendors they should use to build their apps, among other issues. He said this may help speed up adoption, but shouldn't be considered a magic bullet. "It's still not probably serving all the interests that public health would want, but it's better than nothing," he said.

Investigate Alternative Phone Operating Systems

First launched in May, coronavirus tracking software got off to a rocky start. Some public health agencies in the United States and around the world had wanted to build mobile apps that would help them track the spread of the virus, a process known as "contact tracing." But the contact-tracing apps that initially launched did not function properly because of limitations the two tech giants place on mobile apps distributed through their stores. Citing privacy concerns and potential battery drain, Apple and Google declined to give public health

agencies special access for the purpose of contact tracing.

Instead, Apple and Google launched their own software that is built into the operating system. Public health agencies were asked to design their own apps that utilize the software. But the Apple and Google software provides little information to public health agencies.

Tuesday's announcement, the companies said in a joint conference call, may help speed up adoption by allowing states to participate without creating customized apps.

Users who live in states that participate in the software may get a pop-up notification, prompting them to opt into the program. By following simple steps, they can share their Bluetooth data and receive notifications if they come in contact with another participant who has tested positive. Previously, users would have had to download a stand-alone app built by their state. Now, the process is more like changing the settings on the phone.
